Directions:

From the Parkway: Ex.98 = Rte. 195/138 East - to the end -  
turn north onto Rte. 35 - go right at the 1st light = Belmar Blvd. -  
right again at the 1st light = Rte. 71 - look on right

From Route 35 South: Cross the bridge into Belmar -  
take the 4th left (at the Windmill/ Dairy Queen Restaurants),  
go 2-1/2 blocks, look on right after crossing 16th Ave. = Belmar Blvd.  
From Main Street = the Belmar Train Station (Shore Line train from  
Penn Station in NYC or from Newark, NJ): Walk or drive south on Main  
- turn right onto 16th Ave. = Belmar Blvd. - then left onto Rte. 71 -  
look on the right (about 7 blocks from the Train Station).
